

# **Terms and Conditions (OEM)**

## 1 Payment and Shipment

We only accept payment by credit cards and bank wire transfers. Please note that you will be charged 4% or 5% for a credit card transaction. Customers should cover transfer fee. Production will start after a 50% security deposit. The remaining balance is to be settled before the shipment. (Our sales staff will contact you).

It takes from 35 to 60 days after the start of production. This can be subject to custom clearance delays. Please feel free to contact us. We use FedEx, DHL, Brinks, and UPS. Shipping charge will be covered by customers. Shipping insurance can be purchased for package coverage upon the customer's request. Please inform sales staff in advance before shipping.
